

## ПРИЛОЖЕНИЕ 5

### ЧАСТОТНЫЕ СЛОВАРИ НАУЧНОЙ ЭКОНОМИЧЕСКОЙ ЛЕКСИКИ НА ОСНОВЕ ECONLIT

**1. Методика построения корпуса слов и его статистической обработки.** Методика состояла из следующих этапов.

1. Из трёх компакт-дисков с записями Econlit за период 1992—2006 гг. были отобраны два компакт-диска, которые включали записи с 1992 по 2004 гг. (EconLit-AEA, 1992-2004/06) и с 2002 по первое полугодие 2006 г. (EconLit-AEA, 2002-2006/06). Следует отметить, что более поздние диски Econlit могли содержать дополнения для более ранних периодов, выходящих за начальную дату. В частности, на компакт-диске «2002— 06/2006» содержались отдельные записи для 2001 и других предшествующих лет. Поэтому, чтобы исключить дублирования записей, с первого диска были выбраны записи с 1992 по 2001 год, а со второго — с 2002 года по первое полугодие 2006 г. Заметим, что компакт-диск «2002— 06/2006» являлся последним компакт-диском, который члены АЕА могли приобрести для индивидуального использования. С 2006 года члены АЕА получили возможность доступа к Econlit в онлайн-режиме без дополнительной платы. Однако данный режим резко ограничил возможности получения обобщающей информации о публикациях, поскольку максимальный размер кластера составляет 500 работ. Помимо этого, записи выдаются на экран порциями по 20 единиц, которые требуют ряда дополнительных операций по их копированию в буфер обмена и сохранению на жёстком диске. Записи сохраняются в целом и для извлечения полей с текстом (заглавия, рефераты статей, книжные рецензии) требуется дополнительно вырезать эти поля при помощи редакторов текстов и сохранять в отдельном файле. Введенный с 2006 г. режим онлайн и невозможность приобретения по приемлемым ценам EconLit на компакт-дисках крайне ограничили возможность проведения комплексного анализа по всем записям Econlit и пока не позволили нам построить полный словарь с учетом данных за 2006—2010 гг.

2. При помощи программы WinSpirs 5.0, которая предназначена для работы с компакт-дисками EconLit, для каждого года выбрали поля TI, AB и BR, которые сохранялись на жестком диске в формате 92.txt, 93.txt, и т.д. Всего 15 файлов.

3. С помощью программы MS Word каждый из 15 файлов просматривался в режиме замены символов с тем, чтобы заменить пробелами знаки цифр, знаки препинания и служебные знаки, а также знаки переноса строк. Затем оставлялось только по одному пробелу для разделения слов, и в начале файла проставлялся идентификатор года **ру** с соответствующим номером года.

4. С помощью команды копирования в MS DOC все 15 файлов с записями для отдельных лет были объединены в один файл Scr.txt.

5. Файл Scr.txt был обработан при помощи программы FrequencyDictionary.exe (разработчик — сотрудник НГУ А.С. Шевцов). В результате был получен файл RC.txt, в котором по строке идут имя словоформы, и после точки с запятой — их число. Для контроля правильности подсчёта проводился аналогичный подсчет числа словоупотреблений для выборки словоформ при помощи MS Word при помощи команды «Найти».

6. Файл RC.txt просматривался на экране компьютера при помощи программы MS Word с целью дополнительной чистки текста от ненужных знаков и удаления неанглийских слов. При этом обоснованность отнесения словоформ к английскому языку проверялась при помощи программы Lingvo 12. Поскольку в данном пакете были не все экономические термины, найденные в EconLit, то также использовались бумажные варианты толковых экономических словарей типа словаря Б.Г. Федорова<sup>1</sup> и словаря под редакцией А.В. Аникина<sup>2</sup>. Также проводилось уточнение при помощи обращения к записям EconLit и электронным энциклопедиям в Интернете. Например, в результате обработки записей в EconLit было найдено, что аббревиатура **tncs** встретилась 201 раз. В Lingvo 12 находим, что

она происходит от TNC — threaded normalized connector — стандартный резьбовой соединитель. Но на самом деле TNCs — это Transnational Corporations (транснациональные корпорации). Или **rjvs**. В Lingvo 12 подобного сокращения нет вообще. При помощи EconLit, подкрепленным поиском в Интернете, находим, что это обозначает Research Joint Ventures (RJVs), или «Исследовательские совместные венчуры». Это один из видов организаций, который возник в конце XX в. для ускорения инновационной деятельности. Следует подчеркнуть, что задача сопровождения английских словоформ их переводом на русский язык не ставилась, поскольку включение программы Lingvo 12 одновременно с MS Excel позволяет получить перевод слова на экране при наведении на него курсора. Разбор семантических вариантов каждого англоязычного экономического термина представляет собой большую самостоятельную задачу в силу многозначности терминологии, поэтому в дипломе детально он не рассматривается.

7. Поскольку файл RC.txt содержал больше строк, чем могла обработать программа MS Excel, то он был разбит на несколько файлов. Каждый из этих файлов загружался в программу MS Excel. В качестве разделителя использовалась точка с запятой. В результате на листе MS Excel было два столбца: столбец словоформ и столбец ЧС — соответствующих абсолютных частот, или число словоупотреблений. Потом проводилась сортировка словоформ по уменьшению ЧС.

8. На основе визуального анализа информации были отобраны все словоформы с ЧС  $\geq 100000$ . Они были записаны в виде одного столбца в текстовый файл 100000=.txt. Этот файл совместно с файлом Scr.txt обрабатывался программой EconLitProject.exe (разработчик А.С. Шевцов). В результате формировался файл MS Excel, в котором в первом столбце Word перечислялись все словоформы из файла 100000=.txt, в столбце All указывалось общее ЧС для данных словоформ в файле Scr.txt. Затем идет 15 столбцов с ЧС для каждого года для периода 1992—2006. Потом средствами MS Excel для каждой строки исчислялись:  $S1$  — ЧС за 1992—1998 гг.,  $S2$  — ЧС за 1992—1998 гг.,  $DS = S2 - S1$ ,  $T = S2/S1$  (темп роста ЧС).

9. Операция, аналогичная указанной в пункте 8, проводилась последовательно для всех словоформ с общим числом словоупотреблений до 6 включительно.

При построении корпуса слов специально анализировалась возможность отсека «хвоста» с частотами менее 6 словоупотреблений. Так, с ЧС = 6 оказалось 490 словоформ, что в сумме дает 2940 словоупотреблений. Если отнести это число к 32572895 (общее число словоупотреблений), то получится 0,0000922 или 0,00922% (около 0,01%). Добавление примерно 600 словоформ (полная очистка массива не проводилась) с ЧС = 5 — это еще 3000 и прирост общего числа словоупотреблений только на 0,01%. Остается еще в «хвосте»: 1200 словоформ с ЧС = 4; 2000 — с ЧС = 3; 5000 — с ЧС = 2; 20000 — с ЧС = 1. Итого 10,8 тыс. словоформ с ЧС от одного до 5, что увеличивает суммарное число словоупотреблений на 43,8 тыс. Но это всего 0,13% от общего числа словоупотреблений. Прирост точности незначительный, но для подготовки к обработке 10,8 тыс. словоформ потребовалось бы почти две трети времени, необходимого для подготовки 15,1 тыс. словоформ, которые дали 32,6 млн словоупотреблений. Поэтому автор диплома посчитал, что уже созданный корпус слов из 15129 словоформ имеет избыточный запас точности относительно учета малых частот.

10. Полученные итоговые файлы были объединены в один, в котором словоформы могли быть отсортированы по алфавиту, а также по любому показателю, указанному в столбце (по числу словоупотреблений в целом и по каждому году отдельности, по DS, по темпам роста T, и т.п.). В этом файле в итоговой строке определялись суммы по столбцам.

11. Был проведен визуальный просмотр всех словоформ, и они были распределены на следующие пять групп:

- 1) ядро служебных и «строевых» слов (далее ЯССС);
- 2) список фамилий известных экономистов и фирм (имена были исключены) («Персоналии»);
- 3) список значимых сокращения («Сокращения»);
- 4) «География» — список наиболее часто встречающихся географических названий и наименований национальностей (например, во всех падежах Turkey, turkey's, turkish) (включая общепринятые сокращения типа USA, USSR);
- 5) остальные словоформы, которые были отнесены в группу «Термины».

Характеристика этих групп и корпуса слов в целом представлена в табл. П5.1.

Для каждого листа MS Excel со списком словоформ, значений ЧС и показателей S1, S2, DS, T, был создан еще один лист, в котором в каждом столбце приводятся значения ХС — значения ЧС в расчете на 1 млн словоупотреблений. Подобная практика принята в Corpus of American English и ряде других электронных частотных словарях. При расчете были использованы разные варианты: исходя из общего числа словоупотреблений по данной группе (например, «Термины»), исходя из числа словоупотреблений по группам «ЯССС» и «Термины», исходя из числа словоупотреблений по всем группам. Также использовались вспомогательные расчеты для определения процента покрытия текста терминами нарастающим итогом, построения графиков, определения максимальных и минимальных значений по годам, разности между ними, и отнесения этого «размаха» к среднему значению.

**2. Особенности методики частотного анализа словосочетаний.** Для этого анализа также использовалась программа EconLitProject.exe. Кроме файла Scr.txt с текстами из EconLit подавался текстовый файл-шаблон, в котором по строкам перечислялись анализируемые словосочетания. Например, при изучении кризисов был создан файл Crisis.txt, в котором по строкам шли словосочетания “financial crisis”, “economic crisis” и т.д. Вместо файла Scr.txt мог использоваться и другой файл, содержащий тексты, которые было решено подвергнуть частотному анализу на предмет кризисной или другой лексики.

В марте 2009 г. на сайте [www.econlit.org](http://www.econlit.org) был опубликован путеводитель по предметной классификации, в котором были приведены ключевые слова для многих предметных микрообластей. Это дало возможность **впервые** построить вариант частотного словаря на основе EconLit для ключевых слов (отдельных слов и словосочетаний) для каждой предметной макрообласти как для отдельных лет с 1992 по 2005 гг., так и в целом для анализируемого периода. Таким образом получилось еще 19 частотных словарей для ключевых слов 19 предметных макрообластей EconLit (см. табл. П5.2), общим объемом 4358 слов и словосочетаний.

**3. Ядро служебных и «строевых» слов.** Как видим из табл. П5.1, наибольший прирост словоупотреблений будет достигнут при усвоении 43 слов, входящих в группу «ЯССС» (далее первое число в круглых скобках — ЧС, второе — T — темп роста):

Как и во всех других известных частотных словарях английского языка в приведенной выборке подтверждается первенство артиклей, предлогов и союзов. В частности, на долю **the** у нас пришлось 8,2% от словоупотреблений по всем пяти группам слов.

По мнению философа М. Эпштейна, это имеет важное значение и для осмысления философской картины мира: «*Определенный артикль* вообще самое частое слово в тех языках, где он имеется, а на этих языках создана самая богатая словесность в мире: иврит, греческий, арабский, английский, немецкий, французский, испанский... Даже в тех языках, где артикль отсутствует, его различительную функцию отчасти берут на себя указательные местоимения и частицы, от которых он исторически образовался, – «этот», «тот», «такой», «вот», «вон». Для философии всегда было важно найти такое слово (термин), которое заняло бы центральное место в системе понятий и, определяя все другие, само в наименьшей степени подлежало бы определению («Дао» в даосизме, «идея» у Платона, «материя» у Маркса, «жизнь» у Ницше, «бытие» у Хайдеггера...). Определенный артикль, **the**, и есть искомое философское слово слов, выдвинутое самим языком на первое место среди бесчисленных актов говорения о мире. (Исключение составляет лишь еще более

универсальный знак пробела, который лежит в истоке самого говорения и письма). Мир должен быть понят прежде всего через *артикуль* – всесторонне *артикулирован*»<sup>3</sup>.

Анализ отклонений годовых ХС для приведенных 43 словоформ из группы ЯССС от средних значений показал, что наиболее устойчивым является артикуль **a**, а наименее устойчивым — местоимение **we** (не считая ее более неустойчивых **isn't** и **wasn't** с малой частотностью).

**4. Группы «Персоналии», «География» и «Сокращения».** Группу «Персоналии» с ЧС = 3410 открывает фамилия известного экономиста Нэша (Nash).

Прилагательное Keynesian (кейнсианский) по числу словоупотреблений стоит на втором месте с ЧС = 3011. Но если учесть все словоформы, производные от имени Дж. М. Кейнса (Keynes (1789), Keynes' (310), Keynesianism (212), Keynesians (187), Keynes's (806) — в круглых скобках приведены значения ЧС), то Кейнс будет на первом месте.

Третьим по частоте словоупотребления является имя В. Парето (Pareto, ЧС = 2307). В EconLit встречаются как выражения “Pareto optimal”, так и Pareto-optimal (ЧС = 121). Также есть выражения Pareto-efficient (134), Pareto-improvement (23), Pareto-improving (204), Pareto-ranked (44) и некоторые другие с меньшими частотами.

Следующим по частоте стоит имя русского математика А.А. Маркова (Markov, ЧС = 2042), который положил начало всей современной теории марковских процессов, активно используемых при описании случайных процессов в экономике.

Также в числе первых двадцати персоналий мы встречаем имена классиков политической экономии А. Смита, Д. Риккардо и К. Маркса.

Среди географических названий в EconLit наиболее часто упоминается все, что связано с США (включая отдельные штаты и крупные города), на втором месте идет Европа в целом, и ее крупнейшие экономики (Великобритания, Германия, Франция), на третьем месте Азия и Япония. В течение анализируемого периода заметно выросло упоминание в англоязычной литературе таких быстро развивающихся стран, как Китай, Индия и Бразилия. Переход России и других постсоциалистических стран к рынку нашел свое отражение в росте частоты упоминаний названий соответствующих стран и их объединений (СНГ — CIS).

В группе «Сокращения» на первых трех местах располагаются R&D (Research & Development — исследования и разработки, ЧС = 9517), GDP (Gross Domestic Product — валовой внутренний продукт, ЧС = 6244), OECD (Organization for Economic Cooperation and Development — Организация экономического сотрудничества и развития, ЧС = 5760).

**5. Первые четыре наиболее значимых термина.** Такими терминами среди 15086 словоформ, входящих в группу «Термины», будут: economic — экономический (120579; 0,63); model — модель (118648; 0,62); market — рынок (103303; 0,54); policy — политика (100918; 0,53). Первое число в круглых скобках после каждого термина показывает общее число словоупотреблений в целом за рассматриваемый период, второе — процент от общего числа словоупотреблений по группе термины (равно 19110864). Всего это составляет 2,32%. Только для этих четырех терминов ЧС больше 100 тыс. Если перевести проценты в значения ХС (то есть в расчете на 1 млн слов), то получим в среднем за период economic = 6309, model = 6208; market = 5405; policy = 5281.

С учетом всех однокоренных словоформ, учтенных в данном варианте частотного словаря EconLit, картина будет следующей.

**Economic** (120579): economical (301), economically (1962), economic-political (15), economics (37326), economics-based (17), economic-structural (9), economies (22190), economising (9), economist (2046), economists (9084), economist's (279), economists' (373), economize (78), economy (51333), economy's (638), economywide (144), economy-wide (368), Итого: 246751 или **1,29%** от ЧС по группе «Термины».

**Model** (118648): model-based (182), modeled (1532), model-implied (12), modeling (6323), modelled (724), modelling (3931), models (50471), model's (932), models' (103), Итого: 182858 или **0,96%**.

**Market** (103303): marketable (214), market-adjusted (34), market-based (963), market-clearing (146), market-driven (128), marketed (194), marketers (160), marketing (5803), marketing's (11), marketization (194), market-level (47), market-like (45), marketmaker (16), market-oriented (573), marketplace (740), market-related (42), markets (46885), market's (569), markets' (156), market-to-book (84). Итого: 160307, или **0,84%**.

**Policy** (100918): policies (32557), policing (236), policymaker (228), policy-maker (63), policymakers (2014), policy-makers (572), policymakers' (120), policymaking (589), policy-making (856), policy-relevant (97), policy's (76). Итого: 138326 или **0,72%**.

Таким образом, в сумме на долю этих четырех терминов приходится **3,81%** от общего числа словоупотреблений по группе «Термины». Но годовые значения частот ХС будут существенно меняться, о чем свидетельствует график на рис. П4.1.




Рис. П5.1. Изменение частот первых четырех терминов по годам (в расчете на 1 млн словоупотреблений)

Как видно из графика, начиная с 2001 года относительная частота термина *model* постоянно выше, чем *economic*. Важно подчеркнуть, что в экономике термин «модель» используется как в широком смысле — как любой образ (мысленный или условный: изображение, описание, схема, чертеж, график, план, карта и т.п.) какого-либо объекта, процесса, явления, так и в более узком, логико-математическом смысле, как один из методов, входящих в макрообласть С классификации EconLit «Математические и количественные методы».

**6. Наиболее значимые термины EconLit и оценка степени покрытия текста.** Частотные словари могут использоваться для определения степени покрытия текста разными словами (словоформами). Это позволяет оценивать прогресс в изучении иностранного языка. Обычно используются «круглые» значения: 10, 20, 30 и т.д. процентов.

В частотном словаре терминов EconLit, представленном в дипломе, 10% от общего числа словоупотреблений дают следующие 28 словоформ:

economic, model, market, policy, between, more, growth, data, can, analysis, new, countries, results, development, than, also, effects, using, capital, rate, some, social, study, economy, financial, models, two, evidence.

Уровня 20% можно достичь, если освоить еще 49 словоформ:

firms, public, how, when, international, price, may, markets, other, theory, information, income, one, time, use, system, investment, empirical, impact, over, tax, research, rates, case, economics, different, risk, effect, costs, changes, exchange, show, labor, role, under, about, monetary, will, approach, production, based, political, demand, find, prices, government, used, if, industry.

Для достижения 30% от общего числа словоупотреблений по группе «Термины» необходимо взять еще 71 словоформу:

article, into, policies, equilibrium, state, performance, most, states, process, first, index, our, change, examines, important, level, sector, business, employment, all, management, cost, period, world, structure, foreign, work, studies, only, real, interest, value, stock, through, summary, welfare, health, general, do, well, issues, environmental, large, during, efficiency, private, competition, optimal, firm, implications, relationship, national, higher, returns, increase, high, united, university, productivity, factors, three, wage, significant, bank, distribution, where, reform, local, inflation, future, what.

Как видно из рис. П5.2, чтобы быть в состоянии понимать 75% текстов в EconLit, потребуется усвоить 1334 слова.




Рис. П5.2. Зависимость степени покрытия текста от числа терминов

**7. Наиболее значимые слова предметных макрообластей.** Приведем примеры частотных словарей ключевых слов для предметных макрообластей EconLit. Они показывают, во-первых, то макрообласти являются разными по объему уже исходя из предложенных ключевых слов, и, во-вторых, часть ключевых слов входит в разные области. Последнее подтверждает правильность дополнения частотных словарей по отдельным предметным областям общим частотным словарем EconLit, что и сделано в настоящей дипломной работе. Также следует обратить внимание, что в составе предложенных менеджерами EconLit ключевых слов встречаются слова американского и английского вариантов языка.

Приведем примеры частотных словарей ключевых слов для нескольких предметных макрообластей EconLit с числом словоупотреблений 5 и более. Они показывают, во-первых, то макрообласти являются разными по объему уже исходя из предложенных ключевых слов, и, во-вторых, часть ключевых слов входит в разные области. Последнее подтверждает

правильность дополнения частотных словарей по отдельным предметным областям общим частотным словарем EconLit, что и сделано в настоящей дипломной работе. Также следует обратить внимание, что в составе предложенных менеджерами EconLit ключевых слов встречаются слова американского и английского вариантов языка.

**А «Экономикс в целом и обучение»:** economists (9084), bibliography (5744), ethical (2005), ethics (1956), sociology (1713), philosophy (1624), psychology (1136), journals (948), philosophical (806), sociological (698), citations (517), anthropology (408), morality (393), biology (366), physics (329), NBER (276), academia (272), philosophers (208), social economics (183), sociopolitical (165), sociocultural (150), Nobel prize (143), economics departments (133), morals (105), introductory economics (100), social values (99), economics journals (94), radicalism (51), egoism (42), sociobiology (34), АЕА (32), socioeconomics (32), undergraduate teaching (14), graduate teaching (9).
